**CASELOAD:**

Adolescents, grades K-12th. All essential functions are conducted within the framework of cognitive, physical, social, and emotional aspects of the developmental stage.

**MISSION STATEMENT:**

Our mission is to provide a continuum of quality services, which promote the emotional, behavioral, educational, and physical development of children, adolescents, and their families.

**OVERALL PURPOSE:**

This position serves as a special education teacher for programs provided by The Children's Aid Home. Responsible to provide specific educational and individual learning plans for students in those programs.

**ESSENTIAL FUNCTIONS:** (other duties may be assigned)

1. Administer testing programs for the purpose of assessing student competency levels and/or developing individualized educational learning plans (IEP).
2. Assess student competency levels and develop educational curriculum and individual lesson plans based on IEP and academic schedule provided by the school district.
3. Develop an IEP that outlines the educational needs and support services that the student will receive and how often they will be provided (ie. counseling, group sessions, therapy, etc).
4. Review the IEP annually and reassess every three (3) years to update goals, objectives, determine special educational placement/needs, and support services as necessary.
5. Instruct group and individual instruction within established curriculum guidelines.
6. Collaborate with parents, school districts and management for the purpose of improving the overall quality of student outcomes, achieving established classroom objectives in support of the IEP to progress into the standard education curriculum.
7. Collaborate with school district and agency to provide effective sources of teaching tools (ie. books, supplemental materials, computer equipment, etc).
8. Prepare a variety of written materials/documentation (ie. grades, lesson plans, correspondence with parents, students, and school administration, quizzes, attendance, exams, progress notes, etc.) for the purpose of documenting student progress and meeting mandated requirements.
9. Manage student behavior and incorporate behavior management plans and techniques for instructional and disciplinary purposes that will provide an environment of learning.
10. Respond to emergency situations for the purpose of resolving immediate safety concerns and directing to Program Director or Candidate for resolution.
11. Report incidents (ie. fights, suspected child abuse, suspected substance abuse, harassment, etc.) for the purpose of maintaining personal safety of the students, providing a positive learning environment and adhering to school district and agency policies and procedures.
12. Participate in a variety of meetings – IEP, Staff, 9-week grading reviews with school districts, parent/teacher meetings, etc.
13. Participate in performance appraisal process.
14. Attend training, in-service, meetings and conferences as necessary and as directed to obtain hours required by The Department of Education in order to maintain teacher certifications.

**OTHER DUTIES:**

Perform other related duties as assigned.

**WORKING CONDITIONS:**

1. Responding to upset or angry people.
2. Working with frequent interruptions.

**MENTAL/PHYSICAL REQUIREMENTS:**

1. Must possess ability to record, convey, and present information, explain procedures, and follow instructions.
2. Must be able to stand for long periods throughout the workday with intermittent periods of sitting, occasionally bending, climbing stairs, stooping, twisting, and reaching as needed to carry out the essential functions of the job.
3. Dexterity requirements range from simple to coordinated movements of fingers/hands, feet/legs, and torso as necessary to carry out the essential functions of the job.
4. Sedentary work, with occasional lifting/carrying of objects with a maximum weight of 25 pounds.
5. Must be able to practice Nonviolent Crisis Intervention with youth as necessary.
6. Must be able to operate a vehicle.
7. Must be able to talk, hear, read, and write.
8. No special vision requirements are necessary.
